#### Combined Scrutinizer Report on Voting through Postal Ballot and Remote E-voting

Sir,

Ref: Scrutinizer's Report on voting through Postal Ballot including voting through electronic means in terms of Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management & Administration) Rules, 2014.

- A. Pursuant to the resolution passed by the Board of Directors of Forbes and Company Limited (hereinafter referred as "the Company") on 24th January, 2018, I, Makarand M. Joshi, Partner of M/s. Makarand M. Joshi & Co., Practicing Company Secretaries, have been appointed as a Scrutinizer to receive, process and scrutinize the postal ballot process in respect of the Special Resolution set out in the Postal Ballot Notice dated 24th January, 2018 ("Notice").
- **B.** Members approval was sought on the Special Business i.e. Issue of Non-Convertible Debentures on Preferential Basis.
- C. As required under Section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014, the Company completed dispatch of Notice along explanatory statement and postal ballot form on 12th February, 2018.
- **D.** The voting period commenced on 13thFebruary, 2018 (9:00 a.m. IST) and ended on 14th March, 2018 (5:00 p.m. IST) for voting through physical postal ballot form as well as through e-voting.
- E. The remote e-voting facility was provided by National Securities Depository Limited ("NSDL").
- **F.** Particulars of postal ballot forms received including the votes cast through remote evoting have been entered in the Register separately maintained for the purpose.
- G. The physical postal ballot forms were kept under my safe custody in sealed and tamper proof ballot boxes before commencing the scrutiny of such postal ballot forms.

- H. The e-voting were unblocked at 5:00 p.m. on 14th March, 2018and the e-voting summary statement was downloaded from e-voting website of NSDL.
- I. All ballot forms received/votes cast up to 5:00 p.m. on 14th March, 2018 being the last date and time fixed by the Company for said purpose were considered for scrutiny.
- J. I did not find any defaced or mutilated ballot form and all the invalid postal ballot forms were marked and segregated.
